Chairman Dymond called the Regular Meeting of the Franklin Township Board of Supervisors to order on Thursday, October 6, 2016 at 7:00 p.m., at the Franklin Township Fire Hall.

Motion was made by Mr. Dymond, seconded by Mr. Miller to waive the reading of the minutes of the September 1, 2016 Regular Meeting, and to accept the minutes as posted. The motion carried unanimously.

Back Mountain Memorial Library sent correspondence asking for support during their annual fund drive.

NEW BUSINESS

- 1. Mr. Melvin spoke about the Atlantic Sunrise Pipeline project that will be built during the next year. Only a very small portion will extend into Franklin Township near Race Road and Natures Way Lane.
- 2. Mr. Melvin presented the Luzerne Countywide EMS Response Plan recently adopted by the county.

OLD BUSINESS

3. Barry Isett & Associates are formulating a plan to build a salt shed with the grant award of \$100,000.00 received by the township. The plans will be reviewed by the township office and will be forwarded to the State for them to revise a grant contract. Construction will be delayed until Spring at the earliest.

4. Training on the new vactor truck purchased by the members of the BMCP was held, but all township representatives attending the training agreed that more training was needed before attempting to put the truck into service.

Martin Murray asked about putting a door on the salt shed, time frame of laying modified backup on the shoulders of recently paved roads and whether line painting was being considered.
